GENERAL INFORMATION

Priest Lake Search & Rescue Inc. (PLS&R, Inc.) is a “director driven” not-for-profit, private corporation. Each year, one third of the Board of Directors (BOD) is elected to a three-year term by the membership of “Members-In-Good-Standing.” (NOTE: Associate and Honorary Members cannot vote.) [Auth: PLSAR By-Laws, Art. 3, Sect-5, and Art.11]

CERTIFICATION

I am applying to become, or remain, [] a Member-In-Good-Standing, or [] an Associate Member, of PLSAR, Inc. Completed application will be submitted for review at the next scheduled BOD Meeting.

I understand that all training and operations are conducted under the authority and auspices of the Bonner County Sheriff’s Office (BCSO). I also understand my membership within PLS&R, Inc is contingent on me maintaining a membership with the BCSO Emergency Services Unit. I further understand Idaho State Statutes require search and rescue members to be trained in First Aid and CPR. I will avail myself of this training when it is offered, and will maintain my certifications. I understand that if I fail to maintain the required training certifications, I will automatically be reclassified as an Associate Member (without voting privileges), until I meet all of the requirements for Member-In-Good-Standing in accordance with Article 11 of the By-Laws.

I authorize PLS&R, Inc. to retain all State of Idaho Search Reimbursement Funds that are paid as a result of the use of my Personally Owned Vehicle, Snowmobile, ATV, Boat, Dog, Horse, Dive Equipment, or other reimbursable equipment used during authorized missions. Such funds shall be placed on deposit in the PLS&R, Inc General Fund with unrestricted use. (NOTE: State of Idaho Search Reimbursement funds paid as the result of damaged or lost equipment shall be given to the owner suffering said damage or loss.)

I agree to conduct myself, in private and in public, in a manner that reflects positively upon PLS&R, Inc and it membership. I understand that if my conduct brings discredit or condemnation upon PLS&R, Inc, my membership herein may be revoked by the BOD, after a predetermination hearing on this matter.

By signing this application, I certify to abide by the conditions outlined above and acknowledge receipt of a copy of the PLS&R, Inc. By-Laws.
